AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY (TENNESSEE, BY REZONING 1.35 ACRES OF PROPERTY CONSISTING OF WILLIAMSON COUNTY TAX MAP 042, PARCEL 123.01, LOCATED AT 7212 OLD NASHVILLE ROAD, FROM RS-40 (RESIDENTIAL, SINGLE-FAMILY) TO R-15 (RESIDENTIAL), OWNER: JACK LEROND

WHEREAS, the City of Fairview zoning ordinance, and the zoning maps therein adopted be, and the same are hereby amended by rezoning the property herein described as 1.35 acres of property consisting of Williamson County tax map 042, parcel 123.01, located at 7212 Old Nashville Road, from RS-40 (Residential, Single-Family) to R-15 (Residential), property owner: Jack Lerond; and

WHEREAS, said property to be rezoned from RS-40 to R-15 is located within the corporate limits of the City of Fairview; and
