**WHEREAS**, the Aden Woods subdivision is not fully developed, and

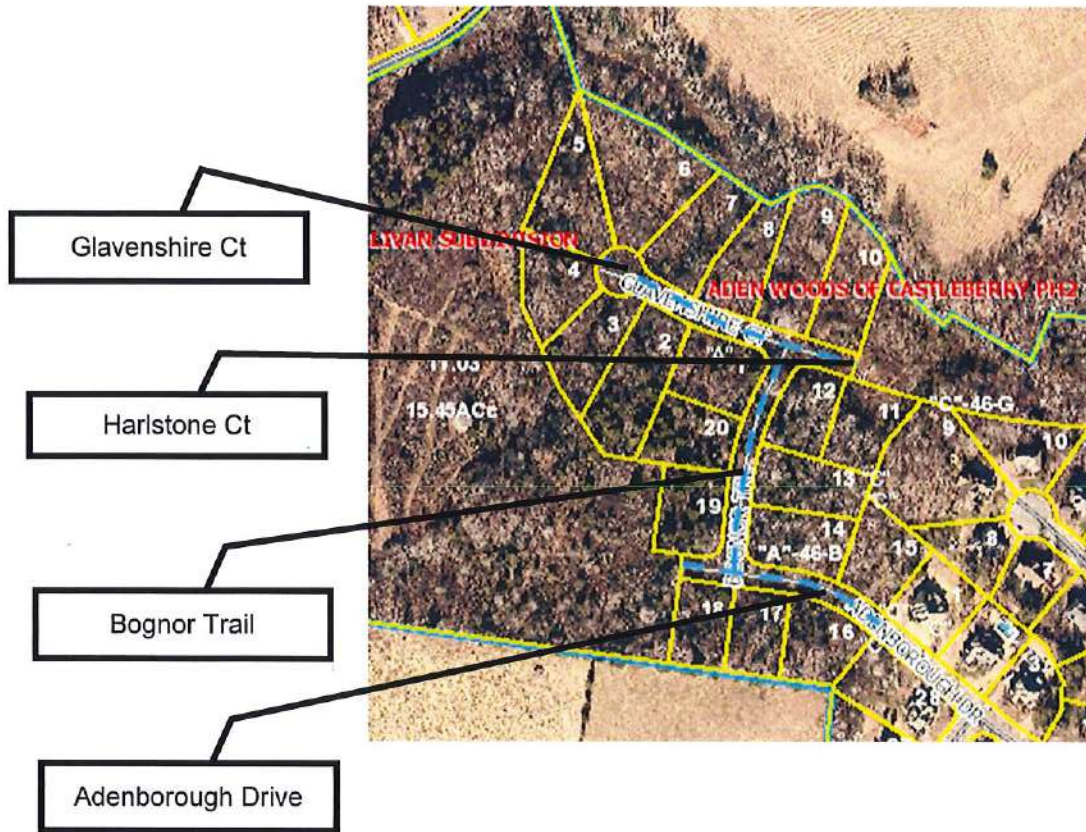
**WHEREAS**, there exists in phase two of Aden Woods subdivision city rights of way that are unimproved and not suitable to the most recent development plan for the development, and

**WHEREAS**, the city desires for all city street rights of way and related infrastructure to be developed and constructed in accordance to standards set forth in the related developer agreements, construction plans, and construction standards, and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF FAIRVIEW, TENNESSEE, AS FOLLOWS:**

The City of Fairview board of commissioners hereby resolves to vacate any and all currently platted and undeveloped rights of way within the current Aden Woods, Phase Two, development area, specifically: Glavenshire Ct, Harlstone Ct, Bognor Trail, and Adenborough Drive northwest of the property lines at 7205 & 7206 Adenborough Drive; and

**BE IT FURTHER RESOLVED** that the city manager is hereby authorized to execute any documents or agreements necessary to facilitate the vacation of these rights of way.
