## AN ORDINANCE FOR AN AMENDMENT TO THE CITY OF FAIRVIEW, TENNESSEE, BUDGET FOR FISCAL YEAR 2016 – 2017 BUDGET

#### Be it Ordained by the City of Fairview, Tennessee as follows:

WHEREAS, the Board of Commissioners of the City of Fairview, Tennessee, have determined that the Budget for Fiscal Year 2016 - 2017 (beginning July 1, 2016 and running through June 30, 2017) should be amended to reflect the final expenditures for the Fiscal Year, and:

WHEREAS, the Board of Commissioners of the City of Fairview, Tennessee adopted the fiscal year 2016 – 2017 budget by passage of Ordinance Number 930 on June 23, 2016, and

WHEREAS, pursuant to the Tennessee state Constitution, Article II, Section 24, no public money shall be expended except pursuant to appropriations made by law, and

WHEREAS, pursuant to Tennessee Code Annotated § 6-56-209, the Board of Commissioners has the authority to authorize the Finance Director to transfer money from one appropriation to another within the same fund, and NOW THEREFORE BE IT ORDAINED BY THE CITY OF FAIRVIEW, TENNESSEE THAT CHANGES BE MADE TO THE FISCAL YEAR 2016-2017 BUDGET AS FOLLOWS:

Section 1. Ordinance 930 is hereby amended to appropriate \$7,400 from the five cent Park fund for lawn mower purchase.

Our current policy for who may or may not speak during the citizens comments agenda item has been very loose. Generally speaking the only limitation is that the comments do not exceed 3 minutes which quite frankly we have never enforced.

The following suggestions are offered to improve the policies:

- 1. The amount of time allotted will be extended to 5 minutes and will be strictly enforced. The chair will stop the speaker at 5 minutes whether they or finished or not.
- 2. The number of speakers will be limited to 5 based upon a first come sign in basis.
- Only resident citizens as defined by the city limits, business or property owners within in the city limits or those persons whose property will be directly impacted by a pending city action are allowed to speak.
- 4. Board members will refrain from entering into a dialogue with the citizen speaker. Any citizen question a board member wishes to address will be addressed during the appropriate agenda item or during Commissioner comments at the end of the meeting.
- Citizens should use proper decorum in addressing the board and address their comments to their concerns and opinions.
- 6. Citizens must be present to speak. Correspondence read by another will not be allowed.
- Repetitive subjects by individuals are discouraged and may be stopped by the Board chair if deemed to be of no additional value.
- 8. Groups wishing to be heard on an issue will choose a spokesperson rather than each member individually speaking.
- 9. Exceptions to this policy may be granted by majority vote of the board.
