## CITY OF FAIRVIEW PLANNING, ZONING, AND CODES FEE AND PERMIT RATES

Effective October 1, 2019, the following fee structure will apply to all planning, zoning, and building code reviews and permits:

One- and Two- Family Residential, New Construction Permits:
Per Ordinance 2023-13 and effective 1/5/2024, Single family detached residential and duplex residential new construction building permit fees have increased from \$1.50 to \$1.85 per square foot.

- $\quad \$ 1.85$ per square foot under roof including storage areas accessible by permanent stairways/doorways.


## One- and Two- Family Residential, Renovation Permits:

- $\quad \$ .50$ per square foot of renovated heated, cooled, and interior storage space.


## Commercial, Industrial, and Multi-family, New Construction Permits:

- \$500 facilities fee, PLUS
- $\$ 3.00$ per square foot for 0-1,000 square foot buildings, under roof.
- \$2.00 per square foot for 1,001-5,000 square foot buildings, under roof.
- $\$ 1.50$ per square foot for $5,001+$ square foot buildings, under roof.


## Commercial, Industrial, and Multi-family, Renovation and Build-Out Permits:

- $\quad \$ .75$ per square foot of renovated space under roof.


## Mechanical Permits, when not included in the building permit:

- $\$ 25$ per HVAC unit installed
- $\quad \$ 25$ per fuel gas line installed


## Accessory Structure and Deck Permits:

- $\$ .25$ per square foot, $\$ 25$ minimum.
