1. Commissioner Sutton called the meeting to order at 7:00 p.m.
2. Commissioner Sutton states that the purpose of the meeting is to Discuss and/or Take Action on an Application submitted by Gary Sherman for an "On Premises" permit for Gary's Place, located at 7006 City Center Way, Suite 201, more commonly known as the former Detour. Sutton asks for an explanation on the item that showed up on his background check. Sherman notes that was regarding an argument with his former wife, charges against him were dismissed and charges were filed against her for falsifying a police report, and she had four years of probation. Commissioner Sutton requested that Sherman bring an authorized document stating this. Sherman replied that he was told it would take up to 6 months and that they wouldn't just give him a letter. Attorney Cantrell states that you need a certified copy of the court order dismissing the charges. Sherman states he was told he could only have them expunged. Cantrell states this is not so. Commissioner Sutton states you can get a certified copy of the court record of the dismissed charges and asks where this occurred. Sherman states it was in Williamson County. Sutton notes he can go to 408 Century Court and to see him after the meeting and he will get the number and help noting this is public record. Vice-Mayor Johnson asks Mr. Sherman to explain how his Spring Hill location works as he has heard it is 21 and up and has heard it is family oriented, so which one exactly is it? Sherman responds that it is 21 and up. The only reason it is 21 and up over there is because he had to make a decision back in 2007 to go smoking or non-smoking. Being that I chose to go smoking, it is 21 and up. Down there you can't have a choice of doing 21 and up at this point and time. If you smoke, it's got to be 21 and up all the time. Johnson asks about the facility he wants to open in our city, which way does he plan to open it? Sherman responds that they are going to open up here as non-smoking so it will be family friendly, after 9:00 we are going to go 21 and up but it will always be non-smoking. Commissioner Sutton notes that if he gets the information asked for, Attorney Cantrell states it will just be the certified copy of your order of dismissal, the other he was talking about is an

expungement of a court order and it is rather expensive. Sutton indicates he understands as he has been dealing with it for about 18 years. Sherman indicates that is what he tried to get before he got here but the girl at the jail said there is nothing like that available, there is only an expungement and that is what she told me. Commissioner Sutton interjects that there is a copy of the court record somewhere. Vice-Mayor Johnson states that he probably already has one and doesn't know it. Sherman states they didn't give him nothing. Cantrell states that with it being the criminal court of Williamson County the Circuit Court Clerk's office. Commissioner Sutton notes that with that amendment, all are in favor. Get to work on that tomorrow and we'll get your permit to you as soon as .. Vice-Mayor Johnson asks when Sherman plans on opening. Sherman responds he guess it depends on when I get this piece of paper but they're trying for a soft opening on the 10th and then an official opening on the 17th.

3. The minutes for the December 19, 2013 Beer Board meeting were presented for approval. Mayor Totty made a motion to approve. Commissioner Sutton seconded. All were in favor.
4. Mayor Totty made a motion to adjourn. Commissioner Sutton seconded. The Beer Board meeting was adjourned at 7:07 p.m.
