6. Consider request from Applicants David Carulla and Nick Carulla with Jefferson's Fairview, 2431 Fairview Blvd, Fairview, TN for an On-Premises Beer Permit.

Representatives: Nick Carulla and Sean McCooey
Discussion: Mayor Anderson asked the representatives if this permit was being
pursued due to new ownership. Mr. Carulla replied that is correct, they have
purchased this location from Mr. Andrew Deal. Mayor Anderson asked the
representatives if everything is in order and about any previous violations. Mr.
Carulla replied everything is in order. Mr. McCooey stated they have twelve
locations in three different states and have been affiliated with Jefferson's
Restaurants for several years. Mr. Carter asked the representatives to explain
what mechanisms they use to avoid serving underage people. Mr. Carulla stated
they use the BARS program where someone comes in once a month to do a
"secret shop" to make sure the server is asking for proper ID. He stated they also
provide training for their servers. Mr. McCooey stated they have a zero-tolerance
policy on the BARS program so if an employee gets a red card they no longer
work for the company. Mr. Carter reminded the representatives that holding a
Beer Permit is a privilege and it can be taken away if the laws are followed.
