A. B. Resolution 16-25, A Resolution calling for a Public Hearing on the proposed Annexation of Territory into the City of Fairview by Owner Consent with RS-40 Single Family Residential Zoning and approving a Plan of Services - 0 Crow Cut Road, 28.75 (+/-) Acres, Map 018, Parcel 031.00. (City Planner)

Staff Report: City Planner Ethan Greer stated this applicants intention is to annex this property and rezone in the future to RS-15 to construct single family homes. Mr. Greer stated this annexation application received a positive recommendation from the Planning Commission. Mr. Greer also stated this property is contiguous with the municipal boundary and is in the city's urban growth boundary. Mr. Greer stated the 2040 Comprehensive Plan has this area listed as a residential high density neighborhood.

Staff Report: City Engineer Curtis Broadbent stated this resolution is to accept the subdivision improvements associated with the Cumberland Estates Subdivision for Phase 1. Mr. Broadbent stated this item received a positive recommendation from the Planning Commission.

Mr. Beavers also stated they will be glad to fix any issues with the curb.

E. Resolution 23-25, A Resolution of the City of Fairview, Tennessee, agreeing to the purchase of specific property and authorizing the Mayor to execute a purchase contract and related documents. (City Manager)

Staff Report: City Manager Tom Daugherty stated this purchase contract is for the two lots to the left of City Center Way which totals 5.34 acres. Mr. Daugherty stated these two lots have been appraised and the seller has agreed to sell at the appraised value. Mr. Daugherty stated he would like for the city to use bond funds to purchase these lots to help secure the campus of City Hall. Mr. Daugherty stated if this item is passed by the board it will require a budget amendment.

Discussion: Commissioner Bufalini asked Mr. Daugherty if the 2.15 million is over ten years or if there will be interest fees. Mr. Daugherty replied that is the sell price and the appraised value. Commissioner Roberts asked Mr. Daugherty to explain where these properties are located and why he thinks it is important for the city to purchase these properties. Mr. Daugherty replied purchasing this property gives the city options for future buildings such as a convention center and also secures some of the city sponsored events. Vice Mayor McDonald asked if the city has looked further into what this land will allow and accommodate as far as what can be built on this property. Mr. Daugherty stated he has not asked for an ALTA survey but stated he does have a survey and the title commitment. Mr. Carter stated the contract is contingent on the city doing its due diligence prior to May 15th. Mayor Anderson stated she feels it is important to secure the campus of the city and buying real estate that can always be sold later is a good use of bond money. Mayor Anderson also stated that without this property the city will not be able to have the July 3rd event. Commissioner Roberts and Commissioner Bufalini agreed with Vice Mayor McDonald on the need for additional due diligence. Mayor Anderson made a motion to defer this item to the next meeting to allow for additional time to review the contract. Vice Mayor McDonald seconded the motion. Vice Mayor McDonald clarified that he is not opposed to purchasing this property he just wants to make sure the city has done its due diligence. Mr. Carter stated he will need to get with the sellers to change the dates on the contract. Mr. Daugherty suggested deferring until the city can get everything done. Commissioner Roberts stated the concerns she had have been answered by reviewing the contract. Mayor Anderson withdrew her motion to defer.

F. Discussion – Future plans for the Bowie Park outparcel (Commissioner Roberts / Commissioner Bufalini)

Commissioner Roberts stated she wanted to discuss this item with the board to potentially put forth a resolution to add the outparcel to the land trust agreement. Commissioner Roberts stated she has been in contact with Mr. Carter and Mr. Daugherty about this and unfortunately right now there are so many properties that have been requested to go into a land trust that there is currently a hold in place and new requests can not be submitted. Commissioner Roberts stated she would like to discuss the future uses for this property. Commissioner Roberts stated the outparcel is an amazing location to preserve green space

in the middle of the city. Commissioner Roberts also stated she would like to retain the natural qualities of the land and keep it as a habitat for animals and for potential park use. Vice Mayor McDonald stated he believes there is limitations on this land due to the topography and the chemical makeup of the soil. Mr. Greer reminded everyone that this property does have deed restrictions placed on it by Ms. Bowie. Commissioner Bufalini shared a handout and discussed his idea of potentially building a Fairview Ag Center on this property.

12. Roundtable: Mayor and Commissioners

Commissioner Bufalini – Commissioner Bufalini recognized the Fairview FCE club for their donation in sponsorships for Camp Bowie. Commissioner Bufalini stated that the Friends of Bowie group is looking for volunteers and encouraged people to sign up and get involved. Commissioner Bufalini asked staff to address the real estate signs that are placed too close to the roadway. Commissioner Bufalini reminded everyone of the seats on various boards that will be coming open in the near future. Commissioner Bufalini encouraged everyone to follow Fairview Live on Facebook. Commissioner Bufalini also encouraged everyone to help local churches. Commissioner Bufalini wished everyone a Happy Easter.
