2. First Reading, Ordinance 2024-01, An Ordinance for an Amendment to the City of Fairview, Tennessee, Budget for Fiscal Year 2023 – 2024 Budget. (City Manager)

Discussion: Mr. Daugherty stated this amended budget constitutes a \$533,852 increase in general fund revenue as well as increase in general fund expenditures. He stated it also constitutes an increase allocation of \$140.500 in additional bond funds to be spent and allocates \$250,000 in ARPA funds to be spent, for a total allocation of \$924,352. Mr. Daugherty went over the increases with the Board. He stated it isn't a huge change and some issues with supply chain has created problems with budgeting for larger items. Vice Mayor Butler asked if most of the revenue increases are based off the first six months of the budget year. Mr. Daugherty replied yes. Mr. Daugherty added that the revenue increased by 5% and the expenditures increased by 5.53%. Vice Mayor Butler asked about the line item increase for donations to the park. Mr. Daugherty stated that is based on the donation from the Historical Association. Vice Mayor Butler asked about fleet increase for the police department. Chief Humphreys addressed the Board stating the PD has the largest increase in expenditures for this amended budget. Chief Humphreys said the police department is understaffed in the patrol division. He stated staffing is something the department wants to address in the next budget year, with the goal of having seven officers on each shift. Chief Humphreys stated this amendment reflects items that are currently hard to get due to supply chain issues in an attempt to get these items before hiring additional staff. Vice Mayor Butler asked if all the unfilled positions are posted. Mr. Daugherty stated all the park positions are full, but the city is pursing positions for public works. Vice Mayor Butler also asked about the increase in workers compensation . Mr. Daugherty replied he received that information after the budget was put out and went off the previous year. Mayor Anderson asked about the line item for plan review services. Mr. Daugherty stated Ms. Bruce is currently training to take over the plan review services for the city hopefully within a year. Mayor Anderson also asked about the engineering services in reference to ARPA. Mr. Daugherty stated that would be paid with ARPA funds. Vice Mayor Butler noted the increase in cellphones. Mr. Daugherty responded that the city is paying far lass now than in previous years and he has a meeting set up next week to try and lower the cost even more. Mayor Anderson noted the \$8000 increase for the Fire Dept equipment operations. Mr. Daughety stated Chief Hughes had asked him to move \$8000 from capital to equipment operations. Mayor Anderson thanked Mr. Daugherty for his hard work on the budget.
