First Reading, Ordinance 2024-05, An Ordinance to amend the Zoning Ordinance of the City of Fairview, Tennessee, by Rezoning .865 (+/-) acres of property located at 7312 Lake Road, consisting of Williamson County Tax Map 042, Parcel 001.01, from RM-40 (Single Family Residential) to RS-15 (Single Family Residential). First Reading, Ordinance 2024-06, An Ordinance to amend the Fairview Zoning Ordinance Article 6: Residential District Regulations, Sections 6-104 Purposes and Intent of AR – Agricultural/Residential Districts, in order to add the Animal Care and Veterinary Services to 6-104.1(2) Uses Permitted with Supplemental Provisions (SUP). (City Planner)

Mr. Chastine stated this would potentially allow both types of veterinary services to be provided at one location. Commissioner Hall addressed concerns with parking and making sure there is ample room for trailers to be able to turn around. Mr. Chastine stated this would be a conditional use and would require approval from the Board of Zoning Appeals at which point they would submit a site plan for review.
