C. Ordinance No. 2018-09, An Ordinance of the City of Fairview, Tennessee Adopting the Annual Budget and Tax Rate for the Fiscal Year Beginning July 1, 2018 and Ending June 30, 2019 — Collins thanked the staff for their hard work on the budget noting it reflects their desire to give the highest level of service in the most fiscally responsible way. We are level staffed for the coming year, don't anticipate purchasing any replacement vehicles, we have budgeted level funding (no revenue increases) and this budget reflects a modest 1 step or 2% raise for all employees. The proposed intergovernmental revenue includes \$753,000 of one-time dollars in and out as reimbursements from the state for the work on the Cumberland Drive/Crow Cut/Highway 100 intersection and multi-modal sidewalk project (both of which we have to cash flow.) Our proposed operating budget is \$200,000 less than last fiscal year. We anticipate an ending balance this fiscal year of \$1,679,000 which is 25% of our operating budget (the state prefers 10% or more so we are well above). Pursuant to our own ordinance we need at least \$284,000 in reserves but we have \$300,000 so we are fully funded. Our debt service is 3.75% of our budget which is really unheard of for municipalities. The threshold max is considered 20% while under 10% is exceptional. We do project a deficit based on one time in/out monies and Collins states he is comfortable with the budget as presented and appreciates the consideration of the board.
