## BOARD OF COMMISSIONERS MEETING MINUTES

May 18, 2017

- 1. Roll Call City Recorder called roll and confirmed the entire Board was present for a quorum.
- 2. Call to order by Mayor Carroll at 7:00 p.m.

- **3. Approval of the Agenda** City Recorder Johnson noted items 12C, 12F and 12G for removal. Vice Mayor Crutcher made a motion for approval with Commissioner Rainey seconding. All were in favor.

- 8. Staff Comments City Manager Collins notes that Mr. Hall and Mr. Paisley are both out sick and our new Planner had a previously scheduled event tonight. First reading of the budget will now be June 1 and the second reading and public hearing on June 15. We are working to complete a list of resurfacing projects to include with the coming budget with estimates to include King Road, Henry Drive and Horn Tavern Road from Bahne Road toward Hwy 96 as well as a small subdivision with only a construction layer. We also learned of an additional \$48,000 in revenue we will receive next year thanks to the recently passed gas tax. This will also be included in the Street Fund for paving.

- C. Second and Final Reading of Ordinance No. 2017-08, An Ordinance to Change the Zoning of Certain Property in the City of Fairview, Tennessee, Located off Fairview Boulevard, Owned by Donald M. Cunningham and Rosemary Cunningham Revocable Living Trust, as Shown on, Williamson County Tax Map 23, Parcel 44.01, From RM-12 to R-20 – Vice Mayor Crutcher read the caption and made a motion for approval with Commissioner Lucas seconding. Owner, Donnie Cunningham was present. All were in favor.
