- 2) Second and Final Reading of Ordinance 2023-03, An Ordinance to amend the Zoning Ordinance of the City of Fairview, by approving the Major Modification Amendment of the Bellehaven Planned Unit Development with 513 residential units on 251.16 acres of property, consisting of Map 021, Parcel 21.01, Applicant: D.R. Horton, Property Owner: Walton Tennessee, LLC.

Discussion: Vice Mayor Butler asked for clarification on the reference made during the public hearing to code section 10-203.3 2L and asked if there is a list of variances or deviations from the code. Mr. Easter replied that the only comment on the plan that referenced a variance refers to critical lots. Mayor Anderson asked Ms. Totty to address the 58 lots listed as critical lots. Ms. Totty explained that lots listed as critical lots will have an asterisk on the plat and will require a separate grading plan to be submitted. Commissioner Street asked Mr. Easter if the 58 lots are all together. Mr. Easter replied no, they are disbursed throughout the neighborhood. Commissioner Johnson asked Mr. Easter how much money they had in the project dedicated to road improvements. Mr. Dowdle responded it was in the 3-4-million-dollar range. There was a brief discussion about the Site Development Agreement and what that would include and who will approve it. Mr. Henry explained the development process, and that this approval would be conditional upon the approval of the development agreement. Commissioner Johnson asked Ms. Totty if the city would be acquiring property for right of way for the road improvements. Ms. Totty replied the intent is for the city to acquire the right of way for the road improvements. Commissioner Street stated in her opinion the application should not be approved because the board does not have definite answers. Mayor Anderson asked Mr. Easter if the variance was denied for the 58 critical lots how would that affect the plan. Mr. Easter replied it would be 58 less lots or the plan would have to be reworked. Mr. Dowdle gave history on why the Hwy 96 connection was removed and stated if the board wants the Hwy 96 connection they would be willing to do that. Mr. Carter advised the board that if they are going to vote against this then they need to have a reason why the plan does not comply with the underlying zoning or other city standards.
