- (7) Discuss Jingo Post Office restoration plan (restore to its current look or to its original look).
- (8) Discuss and make recommendation to move the \$20,000 of un-committed funds into a Fairview Restoration and Historical Fund).
- (9) Discuss Historical Markers (one sided or two sided markers/locations).
- (10) Discuss and make recommendation of Jingo Post Office marker wording.
