12. Roundtable: Mayor and Commissioners

Commissioner Hall – Mr. Hall suggested making a committee for water and sewer and asked the board for their approval to form the committee. For my family and Fairview, I resign as of the end of this meeting from the Fairview Board of Commissioners. I want to thank the people for their support and opportunity to serve.

Mayor Anderson – Mayor Anderson stated it was exciting to see such a crowd at the last meeting and welcomed any groups, teams, or organizations to let the BOC know of their accomplishments so the city can honor them.
