  - Staffing: We have had internal discussions on communications with the public and we have added a role to be housed in city hall to assist with this as well as other roles. We advertised internally and Officer Richard Ross has been selected to fill this role. He will still be a police officer but will move upstairs and transition into his new role as Community Relations Coordinator. We have hired a new officer to fill his vacant role so the police staff will increase by one but Ross will serve as the CRC.
  - Amended Budget: We typically adopt an amended budget the second half of the fiscal year but will do a little different this year and adopt in December. The coming year is election year and we plan on two Focus on Fairview events, one in January and one in March. These will focus on updates in the areas of personnel, operation and financial information as we move toward the election cycle. We will get the calendar for these items out after we adopt the amended budget. January Focus on Fairview will likely be two meetings, one on a weekday and another weekend.

## 11. New Business

A. Lease Agreement on Property Located at 7061 City Center Way – Collins notes we have made an effort to clean up abandoned/dilapidated structures beginning on the Lake Road corridor. One of the most visible properties is the one between City Hall and First Bank and it made sense to follow up on it. We met with the property owner and they were responsive to our suggestions. In keeping with our goal to create a true city center, cleaning up this property would allow for some long-term options to do just that. This is an opportunity at a relatively low cost and we don't see why we shouldn't take advantage of the opportunity. We have the first right of refusal should the property owner decide to sell and the opportunity to purchase at appraised value, not market value. We don't want to miss this opportunity for future ownership and lease payments would be applied toward the purchase price. The Fire Department has engaged in a surplus program similar to the LESO program the Police are involved with. They have secured a lot of park benches, tables with attached seating and trash cans and will be

ours for roughly \$1,000. We will be able to install them throughout the city. While we have not yet bid the demolition we roughly estimate it will cost around \$10,000.
