BOARD OF COMMISSIONERS

November 16, 2006

1. Mayor Brison called the meeting to order at 7:00 p.m.

A. The Prayer and Pledge to the Flag were led by Commissioner Hall.

2. Approval of the Agenda -

A. Arney made a motion to approve the agenda as presented. Hall seconded the motion. All were in favor.

3. Citizen Comments – (Limited to the first five (5) citizens to sign in and a limit of three (3) minutes each)

- A. Jim Beata stated that he was proud to see the director of the Drug Task Force, Joey Kimble, at the meeting and that Vice-Mayor Arney and Chief Harris are working with him on a drug awareness program for the City of Fairview. He stated he is glad the elections are over and despite all the negative campaigning by the Fairview Neighborhood Association they did not get their desired results. He felt it is time the Board gets back to the business of the City. He is glad the Board voted to transfer the ailing water and sewer system to a qualified authority. He hopes they pick the best qualified person for the vacant position and not just the one that makes the most noise.
- B. Lisa Anderson stated that the recent election had a record turn out at the polls. However, there was a dark cloud over the election and its name is the Fairview Neighborhood Association. The name is misleading because only about five members live in the City. She felt the FNA went about the city spreading lies, deceiving, and threatening the business owners and that they removed campaign signs. She further advised that most citizens want to see Fairview grow. She felt the Board should not appoint someone to fill the vacant seat that is sponsored by the FNA.

5. Public Announcements -

A. Forehand reminded everyone that the Christmas Parade will be on December 2nd at 10:00 a.m. and the tree lighting on December 3rd at 5:30 p.m. in front of City Hall. There will be refreshments and caroling.

- B. Chief Harris advised that there have been some telephone solicitations going on and they are calling themselves the Police Protected Fund and that this is a fraud. He advised people to never donate money over the phone.
- C. Vice-Mayor Arney reminded everyone that the annual Chamber of Commerce Dinner will be on November 27th at 6:30 p.m. at the Fairview Recreation Center.

6. Approval of the Minutes -

- A. Presented for approval were the minutes of the Public Hearing held on November 2, 2006. Mangrum made a motion to approve the minutes as presented. Arney seconded the motion. All were in favor.
- B. Presented for approval were the minutes of the Board of Commissioners Meeting held on November 2, 2006. Mangrum made a motion to approve the minutes as presented. Arney seconded the motion. All were in favor.

7. Old Business -

- A. Presented for First Reading was Bill #2006-39: Rezoning of Map 46, Parcel 18.01 from RS-40 to R-20. The property is located off of Crow Cut Road and contains 1.59 acres more or less. Owners Tony and Melissa Cavender Tony Reasons with the Reasons Company. Mangrum read the caption and made a motion to pass Bill #2006-39 on first reading. Hall seconded the motion. All were in favor.
- B. Presented for Adoption was Resolution #34-06: Calling for a Public Hearing to be held on the rezoning of the Cavender Property on December 7th at 7:00 p.m. Mangrum read the caption and made a motion to adopt Resolution #34-06. Johnson seconded the motion. All were in favor.
- C. Presented for First Reading was Bill #2006-40: Amending the City's Sewer Use Ordinance. Mangrum read the caption and made a motion to pass Bill #2006-40 on first reading. Hall seconded the motion. All were in favor.
- D. Presented for First Reading was Bill # 2006-41: Rezoning of the property located at 7221 Keysham Drive from R-20 to AR-5, Map 46, Parcel 25.01 containing 12.35 acres. Owners James N. and Karyn S. Green. Mangrum read the caption and made a motion to pass Bill #2006-41 on first reading. Johnson seconded the motion. All were in favor.
- E. Presented for adoption was Resolution #35-06: Calling for a Public Hearing to be held on the rezoning of the Green Property on December 7th at 7:00 p.m. Mangrum read the caption and made a motion to adopt Resolution #35-06. Johnson seconded the motion. All were in favor.

8. New Business -

A. Discuss and/or take action on a firing range for the Police Department – City Mgr. Forehand stated that she would like permission for the police department to use a portion of what is referred to as the "out parcel" (map 43, parcel 44 containing 24.7 acres) located on Dice Lampley Road as a firing range. They lost their present firing range with the transfer of water/sewer properties to the WADC. (it was located on the sewer plant property) Arney suggested and then made a motion to set aside the entire "out parcel" for the use of the Public Safety Departments. Johnson seconded the motion. All were in favor.

B. Drug Awareness – Vice-Mayor Arney stated that after becoming aware that four students were arrested for drug possession at the high school that something needs to be done about the drug situation in Fairview. He asked Joey Kimble, Director of the 21st Judicial Drug Force, to come and show a video on what using drugs can do. Kimble advised that the video he was about to show has been shown in every middle school and high school in the 21st Judicial District, which includes Williamson, Hickman, Lewis and Perry Counties. He also stated that he would like to work with the City in promoting a drug awareness program. After the 15 minute movie, Kimble advised that the Drug Task Force has started a citizens academy where they talk about drug problems in Williamson County. They do two of these a year in Franklin and invited anyone interested to come and attend their academy. Arney stated that he would like to see the citizens of Fairview more involved in a drug prevention program.

- C. Mangrum thanked Harris and Kimble for bringing this drug awareness to the Board and whatever this Board needs to do make the future brighter he was sure they will do it.
