- D. Resolution on Speed Limits (Revised) City Manager Collins notes we passed a resolution last meeting but two board members requested revisions for this meeting. Revision 1 proposed by Commissioner Rainey was to reduce the speed limit to 40 m.p.h. on Highway 96 from the city limits to the nearest intersection at Kingston Road. The second requested revision was from Commissioner Burks to raise limits on Highway 100 from 35 to 40 m.p.h. from 500' southwest of Cumberland Drive to Old Nashville Road and increase from the Hickman County Line to Overbey Road to 50 m.p.h. Limits within the city not specified above would remain at 45 m.p.h. The Board requested maps at the next meeting to visually see the proposed changes. NO ACTION.
- E. Preliminary Flagpole and Sign Design for Veterans Park Commissioner Burks noted he requested this item be on for status check. Collins states we have done preliminary work on the sign and need to inspect the flag pole. Burks requests deferral to the second meeting in January. NO ACTION.
