- City Planning Staff Micah Sullivan thanked the members of the planning commission and Scott Collins for the work sessions and their thoughts tonight to move this project forward as it will help planning staff a lot. Working as a group to accomplish this goal is very beneficial and he thanked Collins for heading up the work sessions.
- City Manager Collins thanked everyone for all the work tonight and upcoming as the next 90 days will be pretty compressed with the amount of work to do.
- City Engineer, Kevin Blackburn, reported a recent productive meeting with TDEC where they brought their directors and all their field staff to address our concerns on erosion sediment control and stormwater management. Having them as an asset moving forward will be helpful as we work toward the MS4 requirement. We are trying to be a step ahead in this rather than trying to fix something already broken. Collins adds that Blackburn did a great job getting everyone together. We plan to put requirements in place that mirror MS4 in advance of the requirement, including the ISR, as discussed previously. These requirements will be strengthened through zoning and ordinances put into place at the Board of Commissioners level. Both Micah and I have certifications for inspections and the state has helped a lot. Our goal is to eliminate future calls with complaints over what happens downstream. We are also looking for sources of revenue to get ahead of the work required to develop the system and action plan. We will ask to adopt policy and develop an action plan to help pay for it. We will also need to remedy and repair as we move forward. After we complete these zoning revisions we will move toward stormwater regulations in the first quarter of 2021.
