### 1. VICE CHAIRMAN MIKE SMITH CALLED THE MEETING TO ORDER AT 7:00M.

1.1 Lovvorn led the prayer and the pledge.

#### 2. APPROVAL OF THE AGENDA-

5.1 REZONING APPLICATION FOR PROPERTY LOCATED ON HORN TAVERN ROAD. MAP 22, PARCEL 133.00, 8.37 ACRES. FROM RS-40 TO R-20. WALT TOTTY OWNER.

Totty stated Mr. Chairman she would like to make note that she has personal interest on the property on Horn Tavern Road and she will not participate in conversation or voting. Lovvorn stated he was just reporting back to them from last month's meeting.   - 8.1 RECOMMENDATION FROM THE PLANNING COMMISSION TO THE BOARD OF COMMISSIONERS FOR ADVERTISEMENT OF A VACANT SEAT VACATED BY MR. HALL.

Lovvorn read Mr. Hall's resignation. Which will become part of these minutes? Exhibit A. Benson made a motion that they approve the recommendation to the Commissioners for the vacancy. Mitchell Seconded. Smith stated it's either two

possible situations that he sees, one would be a recommendation to get the seat filled, or they could leave the seat vacant if the situation changes that Mr. Hall wants to come back. Smith stated it would be up to them what they wanted to do. Totty stated she doesn't see either way being a negative, moving forward to see what happens, to see if the Board approves the recommendation at that point, who's appointed or who isn't appointed. Totty stated they still have opportunity for solicitation from the citizens. Smith stated he agrees. All were in favor. Smith stated they will recommend to the Board that the seat be advertised.

#### 9. REPORTS FOR DISCUSSION AND INFORMATION

#### 9.1 PLANNING/ZONING/CODES DEPARTMENT -

Lovvorn stated that Commissioner Benson had asked him if he didn't report about the Wal-Mart progress. Lovvorn stated so the last report that he had gotten from them is that they are still on target to turn the building over to Wal-Mart by the end of the month. Lovvorn stated Wal-Mart because of their venders won't have enough time to get the store stocked before the Christmas holidays, so they are still planning on opening the store around the 8<sup>th</sup> to the 15<sup>th</sup> of January. Lovvorn stated it looks like from the site, on site itself that they are still on target to make that deadline. Lovvorn stated the highway looks a little iffy but they will see how they move on that in the next week or so. Benson asked any word from Taco Bell when they may start and break ground. Lovvorn stated Taco Bell is actually in redesign, they didn't like the price that they got quoted for their site work so they probably will be back to this Board sometimes in the near future. Behan asked about Fast Pace. Lovvorn stated they had a preconstruction conference with them, last Friday; they're going to go with the existing building and the approval that they had for that expansion for that facility. Lovvorn stated they will start working the parking lot and try to get it all laid out but they're going to try to stay opened during the construction of part of the facility. Lovvorn stated so it's not going to be very quick construction period, it's going to take them a while.
