GENERAL EVENT DETAILS:

- Event is OUTDOORS and will go on RAIN or SHINE, so please plan accordingly
- Each vendor is responsible for their own signage
- No refunds on fees
- All vendors must provide their own tent canopies, tables, chairs, etc.
- Drilling holes into the asphalt is not allowed
- NO electricity will be provided
- Vendors are responsible for ensuring compliance with all local and state taxes, licenses & permits
- Vendors are responsible for cleaning up their own booth spaces and putting any trash into the City of Fairview bins provided on site
- City of Fairview reserves the right to refuse vendors
- Confirmation of vendor application acceptance will be sent by email (after both application and fees have been received)
- ALL vendors will receive booth location upon arrival for load-in

VENDOR DETAILS:

- Booth spaces are 10' x 10'
- Direct sales vendors are allowed but limited to one of each company
- Booth sharing is allowed for two vendors per booth space
- Vendor booth spaces are on a first come first serve basis and will be limited
- Vendor booth fee is \$35 and must be submitted with application to reserve your spot

FOOD VENDORS:

- Food trucks will be accepted on a first come first serve basis to the first two food vendors
- Food vendor fee is \$50 and must be submitted with application to reserve your spot

APPLICATION DEADLINE: All vendor applications and payment must be turned in by Friday, November 18th

VENDOR SETUP:

- Saturday, December 3rd, arrive between noon and 1:00 p.m.
- Vendors will receive booth location upon arrival.
- After unloading, move vehicles to the designated area **PRIOR** to setting up booths. Vehicles must be moved from the vendor area by 1:30 p.m.
- Booths must be set-up and ready for business by 2:00 p.m. This event is from 2 p.m. until 6 p.m. with the tree lighting to begin at 5:30 p.m.
- Vendors must be completely packed BEFORE moving vehicles. If you need to leave early, the Community Relations Coordinator (Richard Ross) must be contacted prior to breakdown.
